The Civil Aviation Authority of New Zealand (the "CAA") was established under the Civil Aviation Act 1990 as a Crown entity with the prime objective of undertaking activities which promote civil aviation safety, security and other functions in a way that contributes to the aim of achieving an integrated, safe, responsive, and sustainable transport system.

Specific functions include:

- monitoring adherence, within the civil aviation system, to safety and security, access and mobility, public health, and environmental sustainability
- performing entry and exit control over participants in the civil aviation system
- reviewing the functioning of the civil aviation system, including the investigation of incidents and some accidents
- providing information and advice with respect to civil aviation, and fostering appropriate information and education programmes to promote the above objective.
- providing civil aviation related policy advice.
